

Information on the electronic surveillance system set in the area of Ambient Hotel & AromaSPA operated by Sikfürdő Kft.

Dear Guests,

C ACCENT HOTELS

1. Hereby, we inform you that an electronic surveillance system is operated in Ambient Hotel & AromaSPA****, which is located in 5 Fürdő utca Komló-Sikonda H-7300. The electronic surveillance systems of the hotel are operated by a staff member responsible for the technical unit of Sikfürdő Kft.

2. We inform you that the provisions of Act CXXXIII of 2005 on Security Services and the Activities of Private Investigators (hereinafter: Szvtv.), and the provisions of Act CXII of 2011, on Informational Self-determination and Freedom of Information are applicable for the rules of capture, usage and storage of image recordings. The electronic surveillance system is operated as described below, based on the specific consent according to Paragraph 2 of Section 30 of the Szvtv., with the objective to protect the human life, the safety of persons, and the property; in order to prevent or detect infringements or accidents, to surprise the perpetrators in the act, and to prove the infringements. Since the use of the electronic surveillance system involves data management, this activity is under the supervision of the National Data Protection and Information Authority (NAIH).

3. We would like to draw your attention to the fact that, after reading the present note, entering the location monitored with cameras is considered a specific consent to data processing.

4. The registration number of data processing by Síkfürdő Kft. is: NAIH-84864/2015.

5. Scope of processed data: the face and other personal data of guests that can be seen on the image recordings.

6. The electronic surveillance system operates 24 hours on each day of the week.



7. The stored recordings of the camera ^{SIKONDA}llance and recording system operated by Sikfürdő Kft. can only be accessed by authorised persons, exclusively in order to prove infringements against human life, safety of persons and property, and to identify the offender; and in order to reveal other events or accidents affecting the life or safety of persons.

8. Síkfürdő Kft. registers in a protocol the access to captured recordings, the name of the person making the inspection, the reason and time of data accessing. For the safe processing of personal data, the protection of the data stored on the server, described below, is ensured by personalised usernames and passwords.

9. Data transfer is possible exclusively in case of a procedure in progress related to unlawful behaviour or breach of duty, to the authority or court performing it. The scope of transferred data can be the recordings of the camera system containing relevant information, and the names of persons that can possibly be seen on the recordings.

10. We would like to inform you that the affected persons – whose rights or legitimate interests are affected by the image recording – may request a copy of the recordings made about them by the electronic surveillance system; and may request the deletion of the recordings in accordance with the provisions of the legislation in force. Additionally, persons whose rights or legitimate interests are affected by the image recording, may request Sikfürdő Kft. within 3 workdays from the date of image recording not to discard or delete the data after having attested their right or legitimate interest.

We would also like to inform you that you may ask Sikfürdő Kft. to give information on the handling of your personal data at any time. Furthermore, you can also request for the correction, cancellation and blocking of your personal data in compliance with the applicable legislative provisions. In addition, you may object to the handling of your personal data.

We inform you that in case of violation of your rights you may apply to the court in accordance with the provisions of the applicable legislation; furthermore, anybody can initiate an investigation by notifying the National Authority for Data Protection and Freedom of Information, reporting that an infringement has occurred – or there is an imminent danger – in relation with the processing of personal data.

11. The following cameras operate in the area of Ambient Hotel & Aroma Spa:

Camera group 1:

2 cameras covering the area of the hotel's closed car park and the external area of entrances.

The objective of the surveillance is to protect the cars in the car park.

The captured images are stored on the central server for 3 business days. Sikfürdő Kft.'s locally acting head and the hotel manager, or in case the hotel manager is being prevented, the hotel's current manager in charge are entitled to review the camera recordings in the event of the infringements and events described in point 5.

The location of the cameras:

- 1. external camera directed to the closed car park and the technical entrance
- 2. external camera directed to the entrance of the closed car park and the barrier

Camera group 2:

7 cameras monitoring the indoor and outdoor pools operating in the wellness area of the hotel, and their immediate surroundings. The purpose of the observation is to protect life and physical safety, to minimize the chance of accidents occurring in the wellness section and to help the hotel staff respond to any accident in the wellness section as possible.

Furthermore, the placement of the cameras in the wellness area is justified by the property protection objective associated with the fact that visitors take and leave unattended higher-value assets more and more often in the wellness area. The camera images are constantly being watched by the pool attendant.

The captured images are stored on the central server for 3 business days. Sikfürdő Kft.'s locally acting head and the hotel manager, or in case the hotel manager is being prevented, the hotel's current manager in charge are entitled to review the camera recordings in the event of the infringements and events described in point 5.

The location of the cameras:

- 1. internal camera directed to the part of the indoor adventure pool that is equipped with adventure elements
- 2. internal camera directed to the part of the indoor adventure pool where visitors can swim
- 3. internal camera directed to the indoor sitting pool
- 4. internal camera directed to the indoor massage pool
- 5. internal camera directed to the indoor children's pool
- 6. external camera directed to the eastern side of the outdoor adventure pool
- 7. external camera directed to the western side of the outdoor adventure pool

Camera group 3:

7 cameras monitoring the hotel's interior and exterior entrances and various spaces. Primarily, the purpose of the observation is to protect the hotel's properties, assets, inventories, as well as the hotel guests' properties brought into the hotel, on account of which it is particularly justified to monitor the entrances, access roads, reception desk and the store rooms of the hotel. Furthermore, the purpose of the observation is to prevent accidents involving life and physical safety and to reconstruct these events in case of their occurrence.

The camera images are constantly being watched by the staff member being on duty at the reception.

The captured images are stored on the central server for 3 business days. Sikfürdő Kft.'s locally acting head and the hotel manager, or in case the hotel manager is being prevented, the hotel's current manager in charge are entitled to review the camera recordings in the event of the infringements and events described in point 5.

The location of the cameras:

- 1. external camera directed to the western side of the main entrance
- 2. external camera directed to the eastern side of the main entrance
- 3. external camera directed to the rear pedestrian walkway and the rear area of the building
- 4. external camera directed to the rear pedestrian walkway and the rear area of the building
- 5. external camera directed to the rear entrance area of the kitchen and to the access road
- 6. external camera directed to the kiosks and the rear area
- 7. internal camera directed to the area of the Drink bar and the beverage store room
