By submitting an online reservation or by filling in the hotel check-in form, you consent to your personal data being processed in accordance with this Privacy Policy for the purpose of fulfilling your requested services.

We undertake the obligation to keep the personal data of persons using our services as well as those who use our on-line reservation system are confidential and take responsibility for ensuring that we fully comply with the applicable data protection laws at all times. In all respects, we comply with the provisions of the Data Protection Act, such as Act CXII of 2011 on the right of informational self- determination, and on freedom of information ("Info Act") and other applicable regulations.
